Guidelines for Indian Liquid Crystal Society (ILCS) awards

1. General

The ILCS annual awards will be in five different categories¹, as shown below.

Award Category	Age (Y)	Citizenship
I: Sivaramakrishna Chandrasekhar Memorial Lecture	> 60	Any
II: Life time achievement award	> 60	Indian
III: Gold Medal	50-60	Indian
IV: Silver Medal	< 50 (Can be extended up to 60 for exceptional cases)	Indian
V: Bronze Medal	< 50 (Can be extended to up 60 for exceptional cases)	Indian

¹The guidelines to follow, are applicable to categories III-V only unless otherwise stated. Category I and II will be by invitation only, the decision for which will be taken exclusively by the Council. Suggestions for these awards can be made by any of the Council members conveying them to the Secretary of the Society well before the annual national conference of the Society, but surely before 31st August. Lectures by the awardees of these two categories will be placed in prime slots at the conference.

Guidelines for selecting awardees for Categories III-V

- Any ILCS life member, serving as a faculty/staff/researcher in a recognized institute/organization/university, who has been demonstrating professional excellence in the broader area of liquid crystals and closely related topics, is eligible.
- The awards, not involving any monetary component, carries a Certificate/citation signed by the President of the Society and a medallion.
- The awardee has to attend the award function on the inauguration day/concluding day of the ILCS conference. No other person is eligible to receive the award on behalf of the awardee.
- The awardee should deliver the award lecture during the ILCS conference scheduled.

Nomination

- The nomination should be made to only one among the categories III-V
- Nominations for the awards should be submitted in the prescribed format (see above) either by a senior member of the ILCS with at least 10 years of experience in the area of liquid crystals or Head of the department/institution/ fellows of scientific academies.

- iii. Nominations are valid only for the year in which they are submitted. Any member/achiever who has obtained one of these awards is not eligible to apply for another award during the next three consecutive calendar years.
- iv. The duly filled and signed nomination form (the proforma as above) should be submitted to The Secretary, ILCS, at any time during the calendar year, but before 31st August. As a one-time action, in the current year nominations will be considered from the Silver Jubilee year 2017 of the ILCS's inception. Thus, in the current year, the awards are given for the 6-year period, 2017-22. In case of the non-availability of suitable candidates for the aforesaid categories, the awards will not be considered.
